- The Municipality of Cuyapo, Nueva Ecija now invites bids for PURCHASE OF SOLAR LIGHTS. Completion of the above project must be within 30 calendar days. Bidders should have completed within 3 years from the date of submission and receipt of bids a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorship's, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Bid opening shall be on November 19, 2024, 1:30 PM at the 2nd Floor, Gallery Hall, Cuyapo Town Hall, Cuyapo, Nueva Ecija. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
